If the property is 100% owner occupied, and therefore not income producing, please state this in writing on the front of the form and return it to our office.

The enclosed self-addressed envelope is provided for your convenience. The income information must be returned to this office no later than **February 1, 2019** or postmarked by the U.S. Postal Service no later than **February 1, 2019**.
